| <p style="writing-mode: vertical-rl; transform: rotate(180deg);">Program eligibility</p> | <p style="text-align: center;">You meet the Smart and Skilled program eligibility and are eligible for:</p> <ul style="list-style-type: none"> • Entitlement qualifications • Targeted Priority qualifications • Apprenticeships and Traineeships <p style="text-align: center;">Yes</p> <p style="text-align: center;">You will be commencing a Certificate I-IV level qualification from 1 July 2015</p> <p style="text-align: center;">Yes</p> | <p><u>Smart and Skilled program eligibility</u></p> <p><u>Entitlement qualifications</u></p> <p>If you haven't completed a Certificate IV or higher-level qualification, you're entitled to enrol in a subsidised course up to Certificate III (known as Entitlement qualifications).</p> <p><u>Targeted Priority qualifications</u></p> <p>You can enrol in subsidised training at Certificate IV depending on the availability of funding for these courses (known as Targeted Priority qualifications).</p> <p><u>Apprenticeships and Traineeships</u></p> <p>You are eligible if you are a NSW registered apprentice or new entrant trainee.</p> |

| <p style="writing-mode: vertical-rl; transform: rotate(180deg);">Smart and Skilled Fee-Free Scholarship eligibility</p> | <p style="text-align: center;">You will be aged between 15-30 at the commencement of training</p> <p style="text-align: center;">Yes</p> <p style="text-align: center;">You are eligible for:</p> <ul style="list-style-type: none"> • One Fee-Free Scholarship per financial year (from 1 July 2015) • A maximum of two Fee-Free Scholarships over four financial years (ending 30 June 2019) | <p style="text-align: center;">No</p> <p style="text-align: center;">You do not meet the criteria for a Fee-Free Scholarship.</p> <p style="text-align: center;">You are still eligible for a Smart and Skilled concession fee.</p> |
